1. VC&MD has accorded approval to formation of Engineering Cell. This cell will work under the Chairmanship of CE(NMIA) & is as follows :



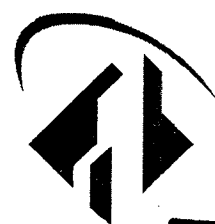
