

RESOLVED FURTHER THAT the Board do and hereby accord approval to take up the deposit work of Development of Palghar District HQ as a Project Management Consultant (PMC) in terms of the draft MoU as per Annexure-III, with PMC charges @9% of the Project Cost with appointment of Architect Consultant by CIDCO."

RESOLVED FURTHER THAT the Board do and hereby accord approval to take up the deposit work of State Blood Transfusion Council (SBTC) for "Construction of Maharashtra Blood Transfusion Academy on Plot No. 74 in Sector-20 at Kharghar, Navi Mumbai" as a PMC (Project Management Consultant) at 10% of project cost which excludes the Architect fees which is to be paid by SBTC to Architect separately as SBTC has already appointed Architect for this project, as per MoU at Annexure-V."
