Clause No. 7.2 Page No. 49 to 50 of E-tender Manual should be read as under:

7.2 Process for RFP/ RFT (Open Tenders or Limited Tenders)

The CIDCO e-tender cycle is divided in total seven (7) stages as follows:

- Bid preparation and release
 Purchase bid document

- 3. Download and preparation4. Bid closing for technical and financial bid
- 5. Bid submission of technical and financial bid
- 6. Bid opening of technical bid
- 7. Bid opening of financial bid

The timelines for the above e-tendering stages are detailed within the table below:

- 1. For works from Rs. 3 to 10 lakhs (Limited Tender), the time required in completing the first call in 15 days & one Bid cycle is 37 days with 2 extensions.
- 2. For works Above Rs. 10 lakhs, the time required in completing the first call is 36 days & one Bid cycle is 68 days with 2 extensions.
- 3. Guidelines of Government of Maharashtra for e-tendering and Manual for procurement by Government Departments have been referred, however based on the practices followed at CIDCO the timelines have been finalized.

4. Timeline mentioned for above activities shall be working days for CIDCO activities only. Time line for vendor activities shall be inclusive of Saturday, Sunday & Public Holiday except all end date of Vendor activities should not fall on Saturday, Sunday & Public Holiday.
